Important Update

Dear Providers,

Earlier this month, Highmark Health Options implemented an update to our Prior Authorization List (PAL) intended to streamline requirements and reduce administrative burden.

During this significant update, we identified an error in which several procedure codes were inadvertently removed from the PAL that required prior authorization. These codes are in the process of being reinstated. We understand that during the brief period when this error was present, our lookup tools may have incorrectly indicated that these services did not require authorization. Please be advised that prior authorization *is*, and *was*, required for these specific codes.

We sincerely apologize for any confusion or inconvenience this error may have caused your practice and staff.

Please find below a listing of the procedure codes that are being restored to the Highmark Health Options PAL. These changes are effective immediately and are retroactive to November 1, 2025.
